LOCATION

C.O.S.S.A Range is located approximately 24 miles east of Bend Oregon. Go here to obtain driving directions to the COSSA Range. COSSA Range GPS Coordinates - N 45° 53.397' W120° 56.458'

By Air:

Fly into Redmond Airport, Redmond Oregon. You will be approx. 14 miles north of Bend. Several Bend Hotels listed have a complimentary airport shuttle service as a part of your stay with them, but do require prior pick-up arrangements, usually 24 hours in advance.

By Ground:

Drive to Bend, Oregon. From Hwy 97, take Highway 20 - East, towards Burns, to mile marker 25 (25 miles). You are just West of Millican, Oregon. Entrance to club is the second or East entrance, past the mile marker on left -just follow the signs.
